REQUEST GOVERNMENT APPOINT OBSERVER AT TRIAL OF ANATOLY SHCHARANSKY—MOTION UNDER S.O. 43

Mr. Douglas Roche (Edmonton-Strathcona): Mr. Speaker, in light of the motion concerning Mr. Anatoly Shcharansky passed unanimously by the House on February 8, and in light of new information that the trial of Mr. Shcharansky on charges of treason may start imminently, I move, seconded by the hon. member for Vancouver South (Mr. Fraser):

That the Canadian government request the Soviet government for permission to appoint an official observer at the trial of Anatoly Shcharansky on charges of treason so that the wide international community of concerned people can be assured that justice is done in this very important human rights case and, further, that the Canadian government repeat its offer to give immediate landed immigrant status to Mr. Shcharansky.

Mr. Speaker: The presentation of such a motion for discussion requires unanimous consent. Is there unanimous consent?

Mr. Speaker: There being unanimous consent, is it the pleasure of the House to adopt the said motion?

UNEMPLOYMENT INSURANCE

SUGGESTION JOB-CREATION PROGRAMS INTENSIFIED TO REDUCE AMOUNT PAID IN BENEFITS—MOTION UNDER S.O. 43

Mr. Edward Broadbent (Oshawa-Whitby): Mr. Speaker, I hope the same spirit of agreement and wisdom will prevail on the motion which I wish to present under Standing Order 43.

Mr. Broadbent: In view of the fact that Statistics Canada just two hours ago released information showing that unemployment insurance payments in 1977 were almost \$4 billion, an increase of 16 per cent over the previous year, and in view

That this House asserts that it is better to pay people to work than pay them not to work, and therefore urges the government to provide job-creation programs which would reduce the \$4.5 billion the government will be paying out in unemployment insurance benefits in 1978.

SUGGESTED REFORM OF MONETARY SYSTEM—MOTION UNDER S.O. 43

That the Minister of Finance (Mr. Chrétien) seriously consider the possibility of reforming our monetary system, more particularly as it relates to the control over credit issuance.
