Order Paper Questions

- 2. The stem of the *Ungava Transport* at the 12' draught mark was punched in for some two feet and the vessel holed. The yacht suffered considerable hull damage. The authority sent a formal notice to Halco, Incorporated, owners of the *Ungava Transport*, holding them responsible for the damages sustained by the authority, as well as the expenses incurred in helping the owner of the *Canari*. Neither the Coast Guard nor the Seaway authority assess liability between vessels in such cases, this being the function of the courts or insurance adjusters. Settlement is still in the course of negotiation between Halco and the owner of the yacht, Mr. John P. Harney of Picton, Ontario.
- 3. The Authority will invoice Halco, Incorporated, an amount of approximately \$14,000.

The seven deaths were all involved in the Cartiercliffe Hall fire which was the subject of a public inquiry.

Many of the reported casualities are of a minor nature.

INSURANCE ON BANK ACCOUNTS

Question No. 2,628—Mr. Cossitt:

PRIVATE RAILWAY CARS

Ouestion No. 2,631—Mr. Cossitt:

- 1. What is a complete list and a description of all private railway cars in the custody or under the direction of the Department of Transport for use by cabinet ministers or other persons?
 - 2. What is a list, by categories of persons, of those entitled to use the cars?

- 3. On what date did the Department of Transport acquire the cars and, in each case, on what date was the car manufactured?
- Mr. Robert Bockstael (Parliamentary Secretary to Minister of Transport): 1. There are presently two units of private railway cars under the custody of the Department of Transport and are described as follows:
 - cars Nos. 1 and 2, a government-owned two-car unit primarily for the use of the Royal family and Governor General but also available for other authorized users with the Governor General's agreement.
 - car No. 5, a single car unit with facilities to accommodate up to seven persons.
- 2. Authorized users of the private railway cars are the Governor General, the Prime Minister, cabinet ministers, and commissioners of the Canadian Transport Commission.
- 3. Railway cars Nos. 1 and 2 were manufactured in 1966 for acquisition by the Department of Transport in the same year. Railway car No. 5 was manufactured in 1929 and was assigned to the Department of Transport in 1967.

- 1. Was railway car number 53 returned to the Canadian National Railways in Montreal from Ottawa on May 21, 1981, by direction of the Minister of Transport?
