fallen over the same period from 33.4 per cent of GNP to 26 per cent of GNP.

- 2. The most comparable figures for the Canadian and United States deficits are those on a national accounts basis, where the per capita Canadian federal government deficit was \$386 in 1979, while that of the United States federal government was \$48. The most comparable debt figures are for the total outstanding unmatured debt. For the Canadian federal government, the per capita value for this series on March 31, 1980, was \$3,018. That of the United States federal government was \$3,946.
- 3. In the Minister of Finance's April 21 address, total public debt charges, including commissions, discounts, premiums and servicing costs, were forecast at some \$10.8 billion for the 1980-81 fiscal year. This represented 17.9 per cent of the projected total outlays of \$60.4 billion for 1980-81. Since that time the Minister of Finance has indicated that the speed of the decline in interest rates is likely to result in debt charges being somewhat lower than in the April forecast. This would result in those charges representing a slightly smaller percentage of total outlays.
