TRANSPORT

EFFECT OF NEW GRAIN TRANSPORT POLICY ON QUEBEC

Mr. Jean-Guy Dubois (Lotbinière): Madam Speaker, I am very pleased with this opportunity to speak under the provisions of Standing Order 21. Yesterday, the Canadian Government announced a new grain transportation policy. Since that announcement, a lot has been said, but in fact, very little has been said, in Quebec. Many Quebec farmers are wondering about the policy and what the implications are going to be. As a Member from Quebec and as Chairman of the Caucus Sub-Committee on Agriculture, we-and I personally-have always been ready to defend the interests of Quebecers as we did in the past for the dairy policy, pork price stabilization payments, the \$33 million policy for the storage of grain and other areas between 1978 and 1983. We shall be going on a speaking tour through Quebec starting on Monday, at Saint-Raymond de Portneuf and Rimouski, to explain our position, to hear what our fellow citizens have to say about this policy and to explain the grain transportation policy to Quebecers and especially to Quebec farmers.

REQUEST THAT LIBERAL MEMBERS DENOUNCE MINISTER'S LIVESTOCK FEED PROPOSAL

Hon. Roch La Salle (Joliette): Madam Speaker, under the same standing order, I would like to make a few comments on

behalf of millions of Quebecers who today are demonstrating their disappointment with respect to the proposals made vesterday by the Minister of Transport regarding this grain policy. Madam Speaker, as a representative of Ouebec and on behalf of Quebec farmers, it is my duty to point an accusing finger at those brave Liberal Members who not long ago were giving the Province of Quebec and Quebec farmers the assurance that all was well. Yesterday's statement is certainly not in line with such assurances and has created a general uproar in Quebec. I think I have every right to demand that the ten Members who formed a committee to ensure the survival of agriculture in Ouebec, have the courage to speak out against these proposals or at least relinquish their seat in the House, if they really care about the rights of Quebec farmers. The reaction in Quebec is very similar to the feelings aroused by the F-18 issue. Once more, Quebec has been betrayed by the Liberal Members from Quebec, who had committed themselves to take action regarding these proposals. In the circumstances, Madam Speaker, I have no choice but to speak out on behalf of millions of Quebecers, our Quebec farmers and ask the Members from Quebec to stand up and censure these proposals which are only going to jeopardize agricultural growth in Quebec. That is my position.

Mr. Blais: Totally irresponsible! The Hon. Member is doing a disservice to his province and his country.

GARRISON DIVERSION

PROPOSED INCREASE IN UNITED STATES FUNDING

Mr. Jack Murta (Lisgar): Madam Speaker, I rise under the provisions of Standing Order 21 to bring to the attention of the House the question of the proposed additional funding for the Garrison diversion project which was indicated a few days ago in the United States Congress. In the 1983-84 year, the Garrison diversion will be receiving some \$22 million, the largest amount it has received in any one year since the inception of the project. From a Manitoba point of view, and I would suspect from a Canadian point of view, this kind of funding is totally unacceptable.
