Mr. McGrath: Mr. Speaker, McCarthy is alive and well in this House—

Some Hon. Members: Hear, hear!

Mr. McGrath: —because the Leader of the Opposition challenged the Minister of Finance after the accusation had been made.

Mr. Nielsen: Exactly.

Mr. McGrath: And the accusation made by the Minister of Finance was that the Leader of the Opposition had somehow benefited financially from his representations to the Minister of Finance.

Some Hon. Members: Hear, hear!

Mr. McGrath: That is what we are talking about here. I say to the Minister of Finance that is not only McCarthy-like, it is sleazy. In any other civilized Parliament, the Minister of Finance would have to resign.

Some Hon. Members: Hear, hear!

GOVERNMENT POLICY—RELEASE OF CORRESPONDENCE WRITTEN BY LEADER OF THE OPPOSITION

Hon. James A. McGrath (St. John's East): Mr. Speaker, let me ask another question of the Acting Prime Minister. Not only the Members of this House, but every citizen of this country has a right to know, even from this Government with its limited mandate, if they can expect to have the privacy of their files respected and if they can expect not to have Ministers of the Government search those files and stand in their place in this House, in a clear abuse of the privileges of this House, and then misrepresent the citizens in a McCarthy-like way.

Hon. Jean-Luc Pepin (Acting Prime Minister): Mr. Speaker, I think that what I said makes it absolutely clear to anybody who wanted to listen that what happened in the particular case to which we are referring was really exceptional. It was very special circumstances, which was the challenge issued to the Minister of Finance who received that document, obviously.

Some Hon. Members: Oh, oh!

Mr. Epp: No way. You can do better than that.

Mr. Pepin: Obviously, what I have said implied, on my part anyway, that this is not something that should be repeated.

With respect to the borderlines between freedom of information, the Secrecy Act—
