GREAT LAKES SCIENCE ADVISORY BOARD

Ouestion No. 4,876-Mr. Mazankowski:

Hon. Allan J. MacEachen (Deputy Prime Minister and Secretary of State for External Affairs): 1. Yes. The Great Lakes Science Advisory Board (known as the Research Advisory Board until November, 1978) is made up of an equal number of American and Canadian members. Presently there are two vacancies on the U.S. side. (a) (b) (i) (ii) See list below. (c) Salaries of Board members are not paid by the Board but are the responsibility of their respective employers.

Travel expenses of those members of the Board who are employees of federal, provincial or state governments are paid by their respective employers. Travel expenses for other members of the Board are paid by the Board.
