DECISION TO ANNOUNCE \$100 MILLION REFURBISHMENT FOR CFB MONCTON

## \*Ouestion No. 87-Mr. Rideout:

- 1. Did the government rely upon particular facts or reports in deciding to announce a \$100 million refurbishment for CFB Moncton in June 1988, and, if so, which ones?
- 2. Were any steps taken by government staff following this announcement and, if so, what were they?
- 3. Did the government rely upon any particular facts in deciding to close CFB Moncton and, if so, which ones?

Hon. William McKnight (Minister of National Defence): 1. Yes, in 1983 a comprehensive survey of CFB Moncton infrastructure was carried out as part of the Base Development Plan. This study recommended the construction of a new 5 Canadian Forces Supply Depot (5 CFSD) to replace present inadequate and widely dispersed facilities. These findings were supported by the recommendations of the Depot Modernization Task Force (DMTF) created in 1985 to analyse deficiencies in the Canadian Forces Supply System. The proposal to replace 5 CFSD Moncton was formalized with acceptance of the projet submission by the Construction Priority Screening Committee (CPSC) in February 1986 and reaffirmed by a review of DND infrastructure carried out in June 1988. The estimate of \$100 million reflects the projected cost to construct and equip a stand alone depot.
