Winnipeg Rails Advance**

MONTREAL, Sept. 2.—Trading during
the first half hour on the local stock
exchange this morning was only fairly
active. Values revealed a firm trend.
The Power issues were firm, the com-
mon being up a half at 97 1/2, while the
preferred sold unchanged at 50. Win-
nipeg Rails advanced a half at 58, while
Alcohol and Abitibi came up unchanged
at 90 1/2 for the former and 21 for the
latter. Laurentide lost a quarter at
10 1/2. The rest of the list was quiet.

Morning Stock Letter
NEW YORK, Sept. 2.—We see no halt
in the bullish activities of the stock
market. The three day holiday at the
end of the week may bring in some profit
taking, but it is a good bet that any re-
action in the near future will be very
small and we look for continued higher
prices. There is still a good deal of
bearishness in the street, and a good
many people are short of stocks. The
technical position, consequently, is much
stronger than it ordinarily is to continue
to work higher, but a good part of
speculation should shift to lower prices.
In this group, Chicago and East-
ern Illinois preferred offers a good spec-
ulation at present prices, and we believe
New Haven will work higher.
Among the high priced issues, Dela-
ware and Hudson should sell consid-
erably above 200.
We continue bullish on the various in-
dustrials we have been recommending,
including N. S. Steel, General Motors,
Air Reduction, Case, International Har-
vester, and U. S. Steel.
American Tobacco should work
considerably higher on the various in-
