ARRESTS MADE IN DANSEY CASE

Charles S. White and a Servant in His Family Locked up

Baby Boy Whose Skeleton Was Found in Clump of Scrub Pines Three Miles Away From His Home

Hammon, N. J., Dec. 11.—Charles S. White has been arrested here charged with the murder of baby "Billy" Dansey. Mrs. Edith Jones, White's housekeeper, was arrested at the same time on the charge of being an accessory after the fact. Both were arraigned before a magistrate, committed without bail and rushed secretly by automobile to the county jail at May's Landing, thirty miles away, lest the aroused countryside should interfere.

The Dansey family disappeared from his home on Oct. 8 and more than six weeks later his body, a mere skeleton, was found in a clump of scrub pines three miles from the home of his parents, Mr. and Mrs. Hercules Dansey, from May's Landing, thirty miles away, lest the aroused countryside should interfere.

The arrests, carried out with the utmost secrecy, were the first intimation that any one in this vicinity was suspected of the crime which had mystified the whole country and aroused so much sympathy that thousands of dollars in rewards were offered for the child's recovery.

From the first the name of White, a Danish farmer, 32 years old, had been interwoven in stories of the disappearance, but there had never been the faintest intimation that he was supposed to have been criminally connected with it. There was a theory that "Billy" had been kidnapped in mistake for White's own child, near his own age and his playmate.

County Prosecutor Edmund C. Gaskill, who came here from Atlantic City to take charge of the investigation into the child's disappearance and supposed murder, refused absolutely to disclose what evidence had led him to bring about the arrest of White and Mrs. Jones. Beyond declaring that weeks of searching into the circumstances surrounding the case justified his action, he was non-committal.

All Hammon, aghast at the sudden turn of the affair and almost dazed with surprise that the Danseys' next door neighbor, a man respected in the community, the father of little "Billy," best friend, had been accused of a peculiarly revolting murder, turned to eager speculation as to what led the prosecutor to act so suddenly and so surprisingly.
