

“ seventh, eighth, ninth and tenth Concessions to where the side line of lots forty and forty-one in the eleventh Concession strikes.”

The said Amendment, being read a second time, was agreed to.

*Ordered*, That the Clerk do carry back the Bill to the Legislative Council, and acquaint their Honors, that this House hath agreed to their Amendment.

The Legislative Council have passed the Bill, intituled, “ An Act to amend the *Lower Canada* Tavern License Act of 1851,” with an Amendment, to which they desire the concurrence of this House : And also,

The Legislative Council have passed the Bill, intituled, “ An Act to amend the Acts relating to Agricultural Societies in *Lower Canada*,” with several Amendments, to which they desire the concurrence of this House : And also,

The Legislative Council have passed the Bill, intituled, “ An Act to authorize the City of *Hamilton* to negotiate a Loan of One hundred thousand pounds,” with several Amendments, to which they desire the concurrence of this House : And also,

The Legislative Council have passed the Bill, intituled, “ An Act to provide for the disposal of Road allowances in the Rural Municipalities of *Upper Canada*,” with several Amendments, to which they desire the concurrence of this House.
