

The affidavit was read by Premier Hazen of New Branswick at a public meeting on October 12th. It also charged that in 1907, Mr Mayes paid certain moneys to Mr Pugeley, but there was an error in date and the affidavit should have read 1905, before Mr Pageley became a member of the Federal cabinet. This error was immediately corrected and the affidavit re-sworn to.

D Daniel attempted to move a resolution calling for an investigation of the McAvity-Mayes transaction and calling on the government to take steps to recover the \$39,700 paid as rake-off to McAvity, but he disposal of the house was taken up with heated arguments over points of order.

Before the motion to go into supply, on which Dr Daniel rose to move for the erquiry, the more recent matter of Mr Pageley's connection with the New Brunswick Railway and Coal Company was referred to.

"I would like to ask the first minister a question," said Mr Foster, " in addition to the one I put to him yesterday, and that is, as to whether he has yet received any copies of the report of the New Brunswick commission and if when he receives

them he will lay one upon the table of the bouse, so that it may, if the house thinks proper, be printed for the information of the members of the house."

Sir Wilfrid Laurier replied : "In regard to the latter request of my honorable friend, I have no hesitation in stating that I do not think we are called upon to lay the document upon the table of the bouse and to have it printed. I may say that I this morning sent to the library to get a copy of that report and I received it about twelve o'clock

Hon Mr Pugsley also observed " May I be allowed to make just one remark: What bas been printed is only part of the report. I think the report must mean the evidence and the documente. It is only when these are printed that one can readily understand what the report really ie."

Dr Daniel began by declaring that the affi lavit of Mr Mayes was on all fours with the charges of Mejor Hodgins which were referred to a special committee to investigate. Yet the government had not moved to appoint a committee to investigate the Mayes charges.

"Does the bon genileman assert that there is an affilavit ?" asked Mr Pug-ley.

"Yes," replied Dr Diniel, " [ bave the sfidavit." (Conservative applause.)

M. Pageley asked that it be sent over to him.

Dr Daniel proceeded to read the affi lavit and when he came to the part connecting Mr Pugsley with




