years and not less than two years, or to be imprisoned in any other gaol or place of confinement for any term less than two years, with or without hard labour, and with or without solitary confinement, and, if a male under the age of sixteen years, with or without whipping.

inflict griev-

30. Whosoever sets or places, or causes to be set or placed, any 5 guns, &c., spring-gan, man-trap, or other engine calculated to destroy human life with intent to or inflict grievous hadily bern, with the intent that the same or wherehad or inflict grievous bodily harm, with the intent that the same or whereby the same may destroy or inflict grievous bodily harm, upon any trespasser or other person coming in contact therewith, is guilty of a misdemeanor, and shall be liable to be imprisoned in the Penitentiary 10 for any term not exceeding three years and not less than two years, or to be imprisoned in any other gaol or place of confinement for any term less than two years, with or without hard labour;—and whosoever knowingly and wilfully permits any such spring-gun, man-trap, or other engine which may have been set or placed in any place, then being in 15 or afterwards coming into his possession or occupation, by some other person, to continue so set or placed shall be deemed to have set or placed such gun, trap or engine with such intent as aforesaid: Provided, that nothing in this section contained shall extend to make it illegal to set or place any gin or trap such as may have been or may be 20 usually set or placed with the intent of destroying vermin.

Proviso.

- Placing wood way with intent to endanger pas-
- 31. Whosoever unlawfully and maliciously puts or throws upon or &c., on a rail- across any railway any wood, stone, or other matter or thing, or unlawfully and maliciously takes up, removes or displaces any rail, sleeper, or other matter or thing belonging to any railway, or unlawfully and 25 maliciously turns, moves or diverts any point, or other machinery belonging to any railway, or unlawfully and maliciously makes or shows, hides or removes any signal or light upon or near to any railway, or unlawfully or maliciously does or causes to be done any other matter or thing, with intent, in any of the cases aforesaid, to endanger the safety 30 of any person travelling or being upon such railway, is guilty of felony, and shall be liable to be imprisoned in the Penitentiary for life, or for any term not less than two years, or to be imprisoned in any other gaol or place of confinement for any term less than two years, with or without hard labour; and if a male under the age of sixteen years, with 35 or without whipping.

Casting upon a railtherein.

32. Whosoever unlawfully and maliciously throws, or causes to fal or strike at, against, into or upon any engine, tender, carriage or truck used upon any railway, any wood, stone, or other matter or thing, with with intent to intent to injure or endanger the safety of any person being in or upon 40 endanger the such engine, tender, carriage or truck, or in or upon any other engine, safety of any tender, carriage or truck of any train, of which such first-mentioned engine, tender, carriage or truck forms part, is guilty of felony, and shall be liable to be imprisoned in the Penitentiary for life, or for any term not less than two years, or to be imprisoned in any other gaol or place 45 of confinement for any term less than two years, with or without hard labour.

endanger passengers by railway.

33. Whosoever, by any unlawful act, or by any wilful omission or anything to neglect of duty, endangers or causes to be endangered the safety of any person conveyed or being in or upon a railway, or aids or assists therein, 50 is guilty of a misdemeanor, and shall be liable to be imprisoned in any gaol or place of confinement other than a Penitentiary, for any term less than two years, with or without hard labour.

Drivers of carriages

34. Whosoever, having the charge of any carriage or vehicle, by wanton or furious driving, or racing or other wilful misconduct, or by 55 ous driving. wilful neglect, does or causes to be done any bodily harm to any person
