Would the minister tell the house on what basis his department made the allocation of the stamp commemorating the 50th anniversary of the first powered flight in the British Empire? COMBINES INVESTIGATION ACT

AMMUNITION-INQUIRY AS TO ACTION ON REPORT

Has the minister received a report from the restrictive trade practices commission saying that Canadian Industries Limited has a restrictive hold on the wholesale distribution of ammunition in Canada? Hon. Sidney E. Smith (Secretary of State for External Affairs) moved:
