CANADIAN CO-OPERATION WITH U.K. ON BALANCE OF TRADE PROBLEMS

Mr. Reid Scott (Danforth): Mr. Speaker, I have a question to address to the Minister of Trade and Commerce. It arises out of a statement attributed to Lord Brown, a joint minister of the British Board of Trade, in which he implied that the Canadian government is dragging its heels in co-operating to help Britain cure its balance of trade problems. In order to clear up any misunderstanding may I ask whether the government has received requests from Britain for co-operation and/or aid in curing its balance of trade problems. If so, what has been the nature of the government's response, if any, to such requests?

Mr. Scott: I rise on a question of privilege, Mr. Speaker. I have just attempted to raise a matter in which the integrity of the Canadian government has been raised and questioned.
