COMPLAINT AGAINST STATEMENT BY JUDGE THAT USE OF ALCOHOL CAUSE OF PROBLEMS

Mr. Lincoln M. Alexander (Hamilton West): Mr. Speaker, I should like to ask the Minister of Justice a question of which I have given notice. Has the hon. gentleman received a letter from the British Columbia Association of Non-Status Indians complaining about the conduct, in terms of language, of a British Columbia Supreme Court Justice, Mr. Justice Gould, in the course of a judgment in which he said the problems of Indians arose from alcohol? Is the minister in receipt of this letter calling for an inquiry and the dismissal of the judge in question, and can he advise the House what action he intends to take?

Hon. Otto E. Lang (Minister of Justice): I have not yet looked at the letter or considered the nature of the complaint. I will do so, of course, and decide at that time whether any action is warranted.

Mr. Alexander: I realize this is a tricky issue, but in view of repeated utterances of such a nature which are certainly affecting the well-being of our native peoples, would the minister take it upon himself to issue a directive or statement for the benefit of the judiciary making it clear that this type of thing cannot be tolerated?

Mr. Speaker: That, of course, is a suggestion or a representation. It is not a question seeking information.
