Mr. René Matte (Champlain): Mr. Speaker, I should like to direct a question to the right hon. Prime Minister.

In view of the particular circumstances resulting from the last federal election, has the Prime Minister explored the possibility of asking each of the political parties represented in the House to participate in the drafting of the different pieces of legislation he wishes to bring down during this session?

Right Hon. P. E. Trudeau (Prime Minister): It would seem such a measure would be hard to implement, Mr. Speaker. The co-operation to which the hon. member alludes should normally take place at the time the bills are discussed, I think. I already indicated in the speech that we would welcome amendments which, in our opinion, would strengthen the fabric of the bills. However much we desire this co-operation I fail to see where a decision on a bill itself, normally taken at the cabinet level, could be shared with the different parties, unless of course, members of those parties accepted to be part of the cabinet.
