BAN ON WHALING—CLOSING OF NOVA SCOTIA PLANT— COMPENSATION TO OWNERS AND EMPLOYEES— ESTABLISHMENT OF NEW INDUSTRY

Since some 67 per cent of the production of the Blandford, Nova Scotia, whaling plant was sold for human consumption and the closing down of this industry places some one hundred shore employees plus ships' crews out of employment, is it the government's intention to establish a new industry in this area to take care of this unemployment, and will compensation be paid to the owners of the whaling plant and its employees?

Hon. Jack Davis (Minister of the Environment): Mr. Speaker, we are looking into measures of the nature of adjustment assistance to help the owners of the property and also to assist the employees to find alternative occupations.

REQUEST FOR COMPENSATION TO FISHERMEN BECAUSE OF DECLINE IN TOTAL CATCH

Mr. James A. McGrath (St. John's East): Mr. Speaker, may I direct a question to the Minister of Fisheries. It is more a related than a supplementary question. In view of the 25 per cent decline in the total fish catch in the Atlantic provinces and in view of what appear to be very serious ice conditions this year which will further reduce the catch, what steps is the minister taking to compensate the fishermen who will suffer severe financial loss as a result of these two factors?

Hon. Jack Davis (Minister of Fisheries): Mr. Speaker, I am happy to report that the total income of fishermen on the east coast is up appreciably; it is up by 10 per cent over that of last year.
