The Constitution

On June 27, 1972, the then hon, member for Wellington complained of the circumstances connected with the tabling of a report prepared by the National Harbours Board. He alleged that the procedure followed did not conform with the law or the Standing Orders. The Speaker ruled that he might have a grievance, but he had not established a case for priority of debate under privilege. With respect, I feel that this matter cannot be accepted under the definition of privilege.

MR. ANDRE—RESEARCH AND DEVELOPMENT—MINISTER'S STATEMENT

Mr. Speaker: Mr. Speaker, on June 8, 1978, the hon. member for Calgary Centre (Mr. Andre) raised a question of privilege in which he alleged that certain figures published in two documents tabled in the House by the Minister of State for Science and Technology (Mr. Buchanan) contained data that "are not fact and are not accurate."

He complained specifically of documents entitled "Research and Development in Canada—Discussion Paper" and "Measures to Strengthen and Encourage Research and Development in Canada."

In his reply on June 15, 1978, the minister acknowledged, and I quote:

Due to an oversight, the footnote to the table in my statement was not amended when the original data, from an August, 1977 publication, were changed to reflect the latest information available.

That having been said, however, I can still come to no other conclusion than that I reached initially during the course of the argument by the hon. member for Calgary Centre, that is, that the matter is not one of privilege, but clearly and fundamentally a dispute as to facts and to the interpretation of those facts and statements and, therefore, ought not to be accepted as a matter of privilege.
