asked him to pass it on to the Minister of Finance. The Minister of Finance promised me he would consider it very seriously. I know he is a busy man, I know he is an overburdened man, but I still hope he will at least have enough time to take a look at it and that he will draw his inspiration from it when he will prepare his budget speech which he is supposed to table in the House in the near future.

Mr. Speaker, these are proposals which I consider serious and useful. I would just like to give the House an idea of what is the very substance of that bill of which I already gave a copy to the Minister of Finance. Here is what its introduction says:

To give Congress the constitutional power to issue money and control its value; to guarantee a minimum income to every American based on a stable and equitable assessment of the dollar whose value should always be high enough to allow the public to buy at will the goods and services that American industries and businesses can make available to them; put an end to the practice by which certain groups of individuals use and create bank deposits with fractional reserves.

This is exactly what is happening in Canada under the Bank Act, and specifically section 72. That is the basis of our system. I would like to reassure bankers, who may be watching us on television, that I am not personally attacking them. I respect them, they are human beings. They inevitably do great service to society, but it is the very system which the act of parliament grants them that I am attacking, because it gives bad results. We know what those results are, I just enumerated them: doubling our debt in nine years and increasing it from \$33 billion to \$67 billion. That is not a normal system. That a government be forced to go down on its hands and knees before financial institutions in order to obtain the funds necessary to administer the country, that is not normal. An individual or a company may be forced to accept such conditions because that is the private sector, it is the pressures of supply and demand, the pressure of competition. Mr. Speaker, I see that it is getting late, but I would like to quote the comments of a taxpaver published in the Wednesday, October 11, 1978, issue of the Journal de Montréal. Sometimes we think that people do not observe us, that they are indifferent to what leaders do, but here is what this man says in an article entitled "The world is heading toward disaster," and I quote:

Yes, you, our leaders, open your eyes, look around you and what do you see? Only depravation. The world is literally heading toward disaster. Animals and plants are disappearing, and you only think of wars and elections. For Heaven's sake, wake up! I think Canada, and indeed the whole world, should invest to save animals and trees. Look at the baby seals, the geese, the whales, make an assessment of the situation and you will see it is disastrous. Wake up and save the world! Be proud of being human beings, but show it. I hope that I have opened your eyes and that you are going to take the steps which are necessary.
