### DELEGATION TO THE NETHERLANDS ON THIRTY-FIFTH ANNIVERSARY OF LIBERATION

Hon. Daniel J. MacDonald (Minister of Veterans Affairs): Madam Speaker, I would like to remind hon. members that May 5 is the thirty-fifth anniversary of the liberation of Holland. Those five dark years of oppression through the Second World War came to an end for that country, but at the cost of thousands of Canadian lives.

I shall lead an official delegation to The Netherlands from May 2 to 9. This delegation will include four senior Second World War Canadian military commanders and representatives of the Royal Canadian Legion and National Council of Veterans Associations. I will also have with me two members of the Senate, two members of the House of Commons and one winner of the Victoria Cross, the Commonwealth's highest decoration for gallantry during the liberation. We will renew the bonds of friendship and respect which have linked the Dutch and Canadian people for well over a generation. We will also share with our Dutch friends deep feelings of sadness for the more than 7,000 young Canadian servicemen who died in that struggle of 35 years ago and now rest in Dutch soil.

The passing years cannot erase in our minds the memory of those gallant men who paid, with their lives, the cost of those great ideals which our countries have come to share and stand for: democracy, freedom and justice.

We can find comfort in the knowledge that Canada's sacrifice from every province of our country and that of thousands of Dutch people during those years was not in vain. The people of Holland rose from the ashes of their war-devastated country to great heights of renewed nationhood. Since that time, 35 years ago, Holland and Canada have enjoyed a fruitful, rewarding relationship, a relationship which will continue to blossom just as The Netherlands Royal Family's annual gift of tulips does here in Ottawa each year around this time.

The links and memories that unite us are strong. We will ensure that they are never allowed to fade. We must also be vigilant to see that the ideals for which Canada fought, and
