Fifteen person-years were necessary to develop a pool of expertise in the fields of corporate and public finance so as to determine the budgetary and economic impacts of private sector assistance in response to financial distress situations.

Thirty person-years were required to permit increased emphasis on economic research in the area of tax policy and legislation. These person-years will also permit a concentrated effort to be placed into the dissemination of public information and consultation with the private sector.

#### DARIUS LEUT HUTTERIAN CHURCH

# Question No. 4,821-Mr. Neil:

Was there a write-off of income tax owing by the Saskatchewan Darius Leut Hutterian Church colony of (a) Arm River (b) Downey Lake (c) Estuary (d) Fort Pitt (e) Hillcrest (f) Hillsvale (g) Hodgeville (h) Lakeview (i) Leask (j) Ponteix (k) Riverview (l) Simmie (m) West Bench and, if so, in what amount?

Hon. Pierre Bussières (Minister of National Revenue): There was no write-off of income tax owing by the Saskatchewan Darius Leut Hutterite Church Colonies cited in the question.

A remission of federal income tax was approved by the Treasury Board of Canada under the authority of Section 17 of the Financial Administration Act, to the Darius Leut Group of Hutterite colonies. The amounts were remitted under order in council P.C. 1981-767, dated March 19, 1981 and promulgated in the *Canada Gazette*, Part II, Vol. 115, No. 7, Registration S1/81-56 dated April 8, 1981. The order implemented a negotiated settlement with the colonies of the Darius Leut Group and remitted federal income tax payable for the 1967 to 1976 taxation years by the colonies of that Group.

The amount of the remission in respect of colony represented the difference between the amounts of income tax assessed that colony for the taxation years 1967 to 1976 and the amount of income tax that would have been payable by the colony for the taxation years 1967 to 1976 if the tax had been assessed against each member of that colony on the basis that the income of the colony was the aggregate personal income of all the members of the colony.
