During 1983, what was the (a) total number of employees (both locally engaged and Canadian personnel) (b) total cost of operating the Canadian High Commission in London?

Hon. Allan J. MacEachen (Deputy Prime Minister and Secretary of State for External Affairs): During 1983, the total number of employees in the Canadian High Commission in London was 344 (214 locally engaged employees and 130 who were Canada based). The total cost of operating the High Commission was \$15,836,695.

Question No. 331—**Mr. Stevens:**

During 1983, what was the (a) total number of employees (both locally engaged and Canadian personnel) at (b) total cost of operating the Canadian Embassy in Paris?

Hon. Allan J. MacEachen (Deputy Prime Minister and Secretary of State for External Affairs): During 1983, the total number of employees in the Canadian Embassy in Paris was 246 (156 locally engaged employees and 90 who were Canada based). The total cost of operating the Embassy was \$15,644,780.

During 1983, what was the (a) total number of employees (both locally engaged and Canadian personnel) at (b) total cost of operating the Canadian Embassy in Washington?

Hon. Allan J. MacEachen (Deputy Prime Minister and Secretary of State for External Affairs): During 1983, the total number of employees in the Canadian Embassy in Washington was 299 (98 locally engaged and 201 who were Canada based). The total cost of operating the Embassy was \$14,169,287.
