departmental officials and the various advisory groups, and in the case of the 1985 salmon fishery there was indeed a surplus in the return to many of the rivers. This is not a loss to the industry, but I think, Mr. Speaker, a recognition of the tremendous benefits of the Salmonid Enhancement Program. I will be discussing that and the next year's fishing plan with my advisory committee in Vancouver on Monday.

#### DATA AVAILABLE TO DEPARTMENT

Mr. Ray Skelly (Comox-Powell River): Would the Minister admit that the data on which that plan is based, on which the consultation takes place, is hopelessly inadequate, and that the cut of 200 staff members from his Department, and the erosion of \$65 million out of its budget are going to make an even worse fishing plan next year, with again very large multimillion dollar losses to the industry?

Hon. Thomas Siddon (Minister of Fisheries and Oceans): Mr. Speaker, I can assure the Hon. Member that the scientific resources of the Department of Fisheries and Oceans are second to none anywhere in the world, and that in any restructuring and improvements to the efficiency of the Department of Fisheries and Oceans there is no question but what those scientific resources will be enhanced, not diminished.

#### **FILM INDUSTRY**

ACQUISITION OF CINEPLEX ODEON SHARES BY AMERICAN CORPORATION

Mrs. Sheila Finestone (Mount Royal): Mr. Speaker, yesterday an American conglomerate became the largest single shareholder of Canada's most important distributor and exhibitor of movies, Cineplex. My question is directed to the Minister of Communications. Since this flies in the face of the many concerns expressed by his task force on the film industry, could the Minister tell this House what he is going to do about this increased concentration and control by American interests?

Hon. Marcel Masse (Minister of Communications): Following this transaction, Mr. Speaker, the Americans will become minority shareholders in Cineplex, and not majority shareholders.

What really matters at this time, as reflected in the reply made by the Minister responsible for Regional Economic Expansion, is the Investment Canada aspect of the question, and the Minister is in contact with his officials and the company first of all, to clear up the legal aspects of the issue.
