Hon. Jake Epp (Minister of National Health and Welfare): Mr. Speaker, I agree with what the Hon. Member has said with respect to some of the issues she has outlined. I have said that myself on other occasions.

Ms. Mitchell: Get on with it, then.

Mr. Epp (Provencher): In terms of consulting with the Minister responsible for the status of women, that has been ongoing, as well as with some other members of Cabinet who have related responsibilities. With respect to the coalition, I have met with them. They have made their presentation to me and have given the reasons why they feel a Royal Commission should be established.

I have not given them an indication as to what position the Government will take, but I have said in this House and other places that I believe the issues of ethics are important. They should be studied. I think too often in medical science and other sciences, that science gets ahead of the ethics of these issues. But I cannot confirm or give the Member any assurance today that a Royal Commission will be established, either in terms of time or in terms of reference.
