Mr. Davies, from the Special Committee appointed to prepare and report the draft of an Address in answer to the Speech of His Excellency the Lieutenant Governor, to both Houses, at the opening of the present Session, presented to the House the draft of an Address, as prepared by the Committee; and he read the same in his place, and delivered it in at the Clerk's table, where it was again read.

Ordered, That the said draft Address be committed to a Committee of the whole House on Monday next.

Ordered, That the Thirteenth Rule of the House be suspended, and that the Hon. Mr. Haviland have leave to introduce a Bill for the amendment of an Act passed in the Sixth year of the reign of Her present Majesty, Queen Victoria, intituled "An Act to repeal an Act made and passed in the Twenty-first year of the reign of King George the Third, intituled An Act relating to Wills, Legacies, and Executors, and for the settlement and distribution of the Estates of Intestates, and to make other provisions in lieu thereof."
