A PROCLAMATION.

WHEREAS at a Session of the Parliament of that part of our Province of Canada, former-1841, promul: of that part of our Province of Canada, formergating the Royal

relief bill. of Toronto, in our said Province, on the third day of December, one thousand eight hundred and thirty-nine, and prorogued on the tenth day of February following, in the third year of our reign, a certain Bill, intituled, "An Act "for the relief of John Stuart," was passed in the Legislative Council and Assembly, and was at the prorogation of the said Session, on the tenth day of February, aforesaid, presented to our Governor-General of our said Province, for our Assent thereto; who, in pursuance of the authority vested in him by a certain Act of the Parliament of Great Britain, passed in the thirty-first year of the reign of His late Majesty King George the Third, intituled, "An Act to "repeal certain parts of an Act passed in the "fourteenth year of His Majesty's reign, inti-"tuled, An Act for making more effectual " provision for the Government of the Province " of Quebec, in North America,' and to make "further provision for the Government of the "said Province," and according to his discretion, then and there declared, that he reserved the aforesaid Bill for the signification of our pleasure thereon. araki bar yakulil

Now Know Ye, that the aforesaid Bill, intituled, "An Act for the relief of John Stuart," having been laid before us in Council, we have been pleased to Assent to the same: And we do by these Presents, according to the provisions of the said Act, passed in the thirty-first year of the reign of His late Majesty King

At Kingston, this eighteenth day of June, in the year of our Lord one thousand eight hundred and forty-one, and in the fourth year of our reign.
