THE COUNTY COUNCIL.

Proceedings of the Members at the Present Initial Session of the New Year.

Much General Work Slighter than last year. Commissioners considered Radial Road.

THURSDAY MORNING.

The county council resumed this morning.

The secretary of the Orford Agricultural Society wrote thanking the council for last year's grant, and asking for a continuation of it.—Referred to Agricultural Committee.

The Public Library Board of Thamestown wrote stating that they had earned \$180 from the government grant and asking continuation of support from the county council.—Referred to Educational Committee.

On motion of Mr. Ross, seconded by Mr. Robinson, Manson Campbell and Lieut.-Col. Rankin were heard.

Mr. Campbell said that a meeting of the citizens had been held yesterday in reference to a radial railway and that Mr. Rankin and himself had been nominated to address the county council.

The charter, granted on January 17th, 1898, providing that an electric railway should be built in this county in three years, had expired on the 17th of January of this year.

The assistance of the county council was asked in petitioning the legislature to amend and extend the charter for three years more. The meeting yesterday felt that if they secured the assistance of the county council in petitioning the legislature that the hands of the railway promoters would be strengthened. The proposed line was to touch Hordenau, Hordenau Springs, Petrolia, Dover Centre, Mitchell's Bay and Pain Court.

Mr. Sturgis, asked why Dresden, the most important town in the county, was not included in the proposed line. He said that Dresden was recognized as the hub of a part of the county of Kent.
