It is with pleasure they inform the shareholders that the conservative policy adopted by your Directors has met with a gratifying result, all branches of the business showing a profit.

The financial crisis has affected the stock market to a great extent, causing a considerable depreciation in the market value of the Company's securities, which, however, are able to stand, as again on the account.

Your Directors have to mourn the loss of one of their number in the death of Hon. William Cayley, an esteemed member of the Board for the past thirty years.

The Directors desire to thank Mr. W. H. Gordon, one of the Company's Trustees in New York, who has facilitated the transfer of his shares to the Company.
