BY CLOSING THE TECHNOLOGY GAP WITH THE USA AND JAPAN. THE BENEFITS OF THE WORLD'S LARGEST SINGLE MARKET PLUS \$10 BILLION IN NEW MONEY FOR R AND D IS GOING TO GO A LONG WAY TO ACHIEVE THAT.

- 10. I HOPE I HAVE GIVEN YOU AT LEAST AN IMPRESSION OF WHY MAJOR DEVELOPMENTS IN EUROPE MATTER TO CANADIAN BUSINESS. AND THE SINGLE MARKET/1992 IS PROBABLY THE MAJOR ECONOMIC DEVELOPMENT IN EUROPE SINCE THE EC WAS FOUNDED IN 1957. IF IT IS SUCCESSFUL (AND EVERY INDICATION IS THAT IT WILL BE) IT WILL SUBSTANTIALLY CHANGE OUR COMPETITIVE ENVIRONMENT. IN SOME AREAS, WE WILL FACE STRONGER EUROPEAN COMPETITION NOT ONLY IN THE EUROPEAN MARKET. BUT IN THIRD-COUNTRY MARKETS AROUND THE WORLD. AND IN OUR OWN NORTH AMERICAN MARKET.
