REMOVAL OF BAN ON ADMISSION OF PERSONS WITH HISTORY OF EPILEPSY

Mr. Les Benjamin (Regina-Lake Centre) moved for leave to introduce Bill C-139, to amend the Immigration Act.

Some hon. Members: Explain.

Mr. Benjamin: Mr. Speaker, in line with efforts on the part of many members for a number of years to secure the entry of certain people to this country as landed immigrants, the purpose of this bill is to amend the Immigration Act so as to remove the ban on persons with a history of epilepsy from being admitted as immigrants to Canada, thus complying with the desire of the former minister of manpower and immigration when he announced last autumn that this would be achieved during the present session.

Motion agreed to, bill read the first time and ordered to be printed.

The subsidization program for bait freezers was discontinued on March 31, 1969 as a result of reduced bait needs of local fishermen caused by the decline in small boat inshore long-line fishing and the move to trawler operations for groundfish.
