

C-3, C-13, C-47, C-33 and C-50. On Tuesday and Wednesday we would like to complete anything that has not been completed in that list, and also add these items which might also be disposed of: Bill C-57, the Federal-Provincial Fiscal Arrangements Act, and Bill S-20, the Territorial Lands Act.

**Mr. Baldwin:** In the event that the Prime Minister, the Minister of Finance, and the Minister of Labour can reconcile their differences so that the Minister of Finance can be delivered of a budget on June 23, will it be the intention of the government to proceed thereafter with the completion of the budget debate and any budget bills that might arise out of that? I know this is in the contemplation of the government, but it might be of some help if this information were available now.

**Mr. Sharp:** Mr. Speaker, I cannot be very definite about this, but certainly the government will want to complete the budget debate itself? I should warn the House that it is quite possible the government will wish to dispose of some of the bills which may result from the budget proposals.

**Mr. Stanfield:** It's going to be a cold summer anyway.

**Mr. Knowles (Winnipeg North Centre):** Mr. Speaker, can the government House leader tell us the present status of the proposed legislation to amend the Old Age Security Act? It has been a long time coming.

**Mr. Sharp:** Mr. Speaker, the bill was finally approved in cabinet today. It is my intention to place notice of the bill on the order paper over the weekend.

**Mr. Fortin:** Mr. Speaker, I should like to make a fresh attempt to have the President of the Privy Council (Mr. Sharp) tell the House when the amendments to the present Unemployment Insurance Act promised in the last throne speech will be brought forward?

**Mr. Sharp:** Mr. Speaker, I do not expect that it will be brought in before the summer recess.

**Mr. Baker (Grenville-Carleton):** Mr. Speaker, on the same point of order, may I ask the government House leader whether he has given any consideration to the striking of the joint committee dealing with the national capital. I understand there might be some expedition of the work of that committee, in the sense that it could deal with briefs over the summer period.

**Mr. Sharp:** Yes, Mr. Speaker. There are a number of other items on the order paper that are not legislative items. There is a motion in my name on the travelling of one of the committees. I have also given notice of the establishment of a committee on the National Capital Commission. I would like to have conversation on this motion through the usual channels. I hope we can expedite these items through the House. In particular, with regard to that committee when it is struck I believe it would be desirable that it hold one meeting before the summer recess so that various documents can be distributed and studied during the summer.

**Mr. Baker (Grenville-Carleton):** Thank you very much.

#### *Business of the House*

**Mr. Beatty:** Mr. Speaker, can the government House leader indicate when the government will be bringing forward the legislation they have been promising with regard to regulation of the federal data banks? It was promised earlier this session. I wonder whether this legislation is going to be delayed until after the summer recess.

**Mr. Sharp:** Mr. Speaker, we have been considering this bill in cabinet. It has now been drafted and I am awaiting an opportunity to introduce it. There is no reason to delay its introduction; I expect it will be very soon.

**Mr. Knowles (Winnipeg North Centre):** Mr. Speaker, I rise on another point of order. A couple of days ago I believe there was agreement to have appended to *Hansard* the full answer to some questions of mine regarding Canadian National pensions. If the Minister of Transport has that information today, I wonder if it could be appended to today's *Hansard*.
