ADVISABILITY OF LOWERING ELIGIBILITY AGE FOR OLD AGE PENSION—MOTION UNDER S.O. 43

That the House require the Minister of National Health and Welfare to take all the necessary steps to introduce in the House this fall a bill lowering eligibility age for the old age security pension to 60 in order to allow workers of that age to leave their jobs, a situation which would have the effect of reducing the unemployment rate that prevails in the main regions of Canada.

CONSIDERATION OF BUDGETARY COMMITMENTS—MOTION UNDER S.O. 43

Mr. Jim Fleming (York West): Mr. Speaker, I rise under the terms of Standing Order 43 on a matter of urgent and pressing necessity.

Considering that the new Secretary of State (Mr. Mac-Donald) now proposes further studies into the federal government's role in the cultural field, and considering that this action follows the Secretary of State's criticisms, while in opposition, of the previous administration for alleged policy inaction and restraint, I move, seconded by the hon. member for Argenteuil (Mr. Gourd):

That this House urges the new government to demonstrate the sincerity of the views of its Secretary of State by bringing into the House for consideration as quickly as possible the six budgetary cultural commitments made by the new Secretary of State to this House on November 24, 1978.
