INFECTIOUS DISEASES IN IMPORTED SHEEP—GOVERNMENT ACTION TO ERADICATE

Mr. Mel Gass (Malpeque): Madam Speaker, I would like to direct my question to the Minister of Agriculture. It involves a serious problem regarding the importation of sheep into Canada. Documented cases indicated that sheep imported from Great Britain have been infected with highly infectious diseases, one being enzootic abortion and the other being pulmonary adenomatosis. During the three-year quarantine period the sheep were not checked for these diseases.

Can the minister assure this House that further importations will be checked more closely for these and other diseases that may be common only in their place of origin? For example, sheep are soon to be imported from France: will these sheep be checked more closely while in quarantine, or will some other infectious disease be confirmed after the sheep are dispersed to the public?

An hon. Member: He has pulled the wool over our eyes.

Hon. E. F. Whelan (Minister of Agriculture): Madam Speaker, that such a thing as the hon. member has described could happen is of great concern to my department. We regard

the Canadian quarantine system as the best in the world. However, that does not mean that it does not have some problems, or that it will not make mistakes. This problem which seems to exist in some of the flocks which have been imported has been double-checked. I am sure the hon. member is aware that the only way to check the sheep for disease is by slaughtering them.

Miss MacDonald: That is pretty final.

Mr. Whelan: The hon, member has also mentioned sheep which will be imported from France. Every precautionary measure known will be taken when these sheep are put into quarantine at the Grosse Isle quarantine station.

Mr. Gass: Madam Speaker, contrary to what is said, there is a way of checking for enzootic abortion, and it is not by slaughtering the ewe. It can be done by checking the foetus after it has been aborted. This method was not practiced during the three years of quarantine in Prince Edward Island and Cape Breton.

Is the minister considering compensating farmers who have purchased these diseased sheep from government-run importation groups for the purpose of improving their flocks? If so, what form will the compensation take?

Mr. Whelan: Madam Speaker, if proof can be shown that the problem was due to some neglect on the part of the officers in charge of the quarantine, then proper compensation will be made to the people who purchased these sheep. We value very highly the record which we have because, as I have said, it is one of the best records in the world. Because of our ability to provide disease-free sheep, we have a great export business.

What the hon, member has said about enzootic abortion is true, but I understand that it was not brought to the attention of our veterinarians, otherwise tests could have been carried out much sooner than they were.
