##### Question No. 72—Mr. Nunziata:

1. Of those presently incarcerated in federal correctional institutions, how many are (a) male (b) female?
2. How many inmates convicted of murder were released from the correctional system during the past five years after having served their sentences and, how many were subsequently convicted of a further indictable offense?
3. How many inmates in the federal correctional system are currently serving life sentences for murder and manslaughter?

**Hon. Elmer M. MacKay (Solicitor General of Canada):** In so far as the Correctional Service of Canada is concerned:
