It contains the signatures of over 150 Canadian seniors. They reside not only in my riding of Hamilton West but in Dundas, Burlington, St. Catharines, Stoney Creek, Brantford, Scarborough, Unionville, North York, Grimsby, and Fenwick, just to name a few.

They state that since 1952 Canadians made additional tax payments for the sole purpose of funding the old age security programs and not for the purposes of balancing federal and provincial government budgets.

They request that the federal government immediately affirm the right to all Canadians to receive universal access to benefits of old age security payments by cancelling plans to introduce a clawback tax regime on old age security payments.

POSTSECONDARY EDUCATION
