Mr. Speaker: The hon. member was recognized for the purpose of asking a question. May I point out that we are running short of time.

Mr. Gilbert: My question is directed to the minister responsible for housing. In view of the fact that the minister has promised on different occasions to make a statement on the policy on urban development and public housing, will he fulfil that promise by making a statement on motions next week setting forth the government's policy in these matters?

Hon. Robert K. Andras (Minister without Portfolio): Mr. Speaker, as sometimes occurs, there is a slight distortion in the premise on which the hon. member's question is based. I made no commitment to make a full statement on the policy regarding urban development and public housing at any given time. What I said was that I would be meeting the officials of the provinces to establish new criteria for public housing, and that I would do my best to deal with the urban renewal projects as soon as possible. That date of decision is getting closer every day that goes by.

DEVCO—COMPULSORY RETIREMENT OF MINERS

Mr. Donald MacInnis (Cape Breton-East Richmond): Mr. Speaker, I have a question for the Prime Minister. I wish to ask him whether he and his government endorse the compulsory retirement at the age of 60 of Devco employees?

Mr. Speaker, I have a further question for the Prime Minister. I do not wish to rush him but I want to ask him whether he cares to carry out the promise which he made on April 14 to answer the question which I put to him.

Mr. Speaker: The hon. member has asked his question and, as he knows, if there is no reply given to it or if he is unsatisfied with the reply, there is not much that he or the Chair can do about it.

Mr. MacInnis: I wish to give the Prime Minister one more chance, and ask him whether he accepts the remarks made by his own Minister of Regional Economic Expansion in which he admits there is discrimination by Devco against Cape Breton miners? What is he going to do about it in his "just society"?
