CRISIS IN VALUE OF CANADIAN DOLLAR

Madam Speaker: I have notice of a motion under Standing Order 26 in the name of the hon. member for Oshawa (Mr. Broadbent).

Hon. Edward Broadbent (Oshawa): Madam Speaker, I ask leave, seconded by the hon. member for Kamloops-Shuswap (Mr. Riis), to move the adjournment of the House under Standing Order 26 for the purpose of discussing a specific and important matter requiring urgent consideration, namely, the crisis in the Canadian dollar, which has reached its lowest point in history in comparison with the U.S. dollar, a fact which is directly related to the failure of the government to announce its intention not to proceed with measures related to last fall's outdated budget, the collapse of the government's energy program and the related failure of the government to produce a new economic policy for Canada.
