

The House proceeded to take into consideration the amendments made by the Senate to the Bill intituled : "An Act to amend the Acts incorporating the *Brockville* and *Ottawa* Railway Company, and the *Canada* Central Railway Company, and "to provide for the amalgamation of the said Companies," and the same were read.

Ordered, That the amendments be read a second time on Wednesday next.

The House, according to Order, resolved itself into a Committee on the Bill to make provision for the winding up of Insolvent Incorporated Fire or Marine Insurance Companies, and after some time spent therein, Mr. Speaker resumed the chair ; and Mr. *Irving* reported, That the Committee had gone through the Bill, and directed him to report the same, without any amendment.

Ordered, That the Bill be read the third time To-morrow.

The House, according to Order, resumed the adjourned Debate on the amendment which was, on Thursday last, proposed to be made to the Question, That Mr. Speaker do now leave the Chair (for the House again in the Committee of Supply) ; and which amendment was, That all the words after "That" to the end of the Question, be left out, and the words "it be resolved, That the recent dismissal by the Lieutenant-Governor of the Province of *Quebec* of his Ministry was, under the circumstances, "unwise and subversive of the position accorded to the advisors of the Crown since "the concession of the principle of responsible Government to the British North "American Colonies," inserted instead thereof ;
