III IS Excellency the Lieutenant-Governor lays before the Assembly, and recommends to their consideration, a Copy of a Letter from Sir Howard Douglas, the Lieutenant-Governor of New-Brunswick, representing the inconvenience perienced by Vessels belonging to, or trading with, that Province, from the mode in which they are made to contribute towards the support of the Light-House on Cranberry Island.

His Excellency also lays before the Assembly, a Copy of a Letter from Colonel Ready, the Lieutenant-Governor of Prince Edward Island, and a Copy of a Petition addressed to him by several Merchants of that Island, on the same subject.
