Ordered, That the Clerk do carry the Bills to the Council, and desire their concurrence.

A Bill in further addition to the Act relating to Highways, Roads and Bridges. A Bill concerning Elections in the County of Shelburne.

A Bill in amendment of the several Acts, relating to the Registry of Deeds, were severally read a second time.

Resolved, That the Bills be committed to a Committee of the whole House.

A Bill relating to Assessments of Poor and County Rates, was read a second time. Assessment Bill Resolved, That the Bill be referred to a Select Committee, to examine and report referredto a select Committee upon the merits thereof.

Ordered, That Mr. Haliburton, Mr. Harris, Mr. J. Morton, Mr. Dickson and Mr. Freeman, be a Committee for the above purpopose.
