- *Question No. 90, by Mr. Knowles,—Order of the House for a Return showing: 1. How many persons who were candidates in the federal election of June 18th, 1962, and were defeated, have since that date been appointed by the federal government to positions to which emoluments are attached?
 - 2. What are the names of all such persons?
 - 3. What are their positions, and what are their emoluments?
- *Question No. 108, by Mr. Herridge,—Order of the House for a Return showing: 1. Was there a meeting in Ottawa in the summer of 1962 concerning the disposal of radioactive wastes, including disposal in the ocean and, if so, what were its findings?
- 2. Has the government considered the report of the *ad hoc* panel of the International Atomic Energy Agency with regard to disposal of radioactive wastes?
- 3. Has the government any knowledge as to whether any dumping of radioactive wastes has taken place at a dumping site 150 to 200 miles South of Yarmouth during 1960 or to date and, if so, is this site still considered a possible dumping area by the U.S. Atomic Energy Commission?
- 4. Has the government any knowledge of the official views of Britain, France, and the USSR with regard to disposal of radioactive wastes in the ocean and, if so, what are they?
- *Question No. 114, by Mr. Cook,—Order of the House for a Return showing: What stage has been reached in the negotiations towards making Canadian lumbermen, who have worked in the State of Maine, eligible for unemployment insurance benefits when they are out of work?
- Mr. Hales, Parliamentary Secretary to the Minister of Labour, presented, —Return to the foregoing Order.

Question No. 120, by Mr. Fisher,—Order of the House for a Return showing: 1. Has the government received any requests for information or assistance from the U.S. Senate Armed Services Committee or one of its sub-committees about the operations in Canada of Mr. George M. Humphrey in the mining and metal industry or about any of the companies operating in Canada with which Mr. Humphrey is associated as an official or director?
