Rt. Hon. Sir WILFRID LAURIER (Prime Minister). No special reference is made in the Commission to any particular form of life insurance, but the Commissioners have full authority to investigate fraternal insurance as well as other forms of insurance when carried on by companies operating under Dominion charters or under Dominion license.

Action in the matter was taken on the

report of the post office inspector.

Mr. Talbot was appointed to the office on

April 1, 1890.

There had been complaints from time to time in regard to the management of this post office.

Mr. William McPherson was, on January

16, 1906, appointed to the office.
