Has the board of broadcast governors and/or the Department of Transport received an application from North Shore Community Television Ltd. of Kedgwick, N.B., for permission to microwave from Kedgwick, N.B., to Campbellton, N.B., signals originating from an American television station and (a) if so, was said permission granted and (b) if not, what reasons for refusal were given to the applicant?

Mr. McBain: Yes, an application was received by the Department of Transport, (a) no, (b) the licensing policy applied in this case is that the department may give consideration to an application which is predicated on the use of a radio relay where the programs are to be received from a transmitting station located in the United States, provided that the area does not receive any Canadian television service either directly or by C.A.T.V.
