

ENFORCEMENT OF LAW REQUIRING PERSONS  
RECEIVING UNEMPLOYMENT INSURANCE BENEFITS TO  
MAKE THEMSELVES AVAILABLE FOR WORK

**Mr. David Lewis (York South):** Mr. Speaker, since a statement by the Prime Minister of the country may easily be believed by people across Canada—

**Some hon. Members:** Oh, oh!

**Mr. Lewis:**—easily and unfortunately, Mr. Speaker—

**Some hon. Members:** Oh, oh!

**Mr. Lewis:**—and in view of some of the statements the Prime Minister has made, may I ask these questions, not as nitpicking but because they are important for the understanding of the people of Canada. Is the Prime Minister aware that the Unemployment Insurance Act requires a person seeking to draw unemployment insurance benefits to make himself available for work? As he made the statement there are people who prefer not to work and to take unemployment insurance benefits, is the Prime Minister doing anything to get the present law, not any new law, enforced so that people who draw unemployment insurance benefits do in fact make themselves available for work?

**Right Hon. P. E. Trudeau (Prime Minister):** I think the answer is very simple, Mr. Speaker. A person who does make such an application, which he is obligated to do under the law, is not obliged to accept any job that is offered to him at any salary and at any place in the country. I would have thought the hon. member would know of such a provision in the law.

**Mr. Speaker:** Order, please. I will recognize the hon. member for York South and there are four or five additional members seeking supplementaries. We have spent ten minutes on the first question. Perhaps we should limit the number of supplementaries and, if there is time, eventually return to this matter. For the moment the Chair will recognize the hon. member for York South on a supplementary.

AVAILABILITY OF JOBS FOR UNEMPLOYED

**Mr. David Lewis (York South):** Your Honour may wish to treat this as an original question rather than a supplementary. Is the Prime Minister saying that there are some jobs available, which no doubt there are on any given day, but jobs at very low wages and in undesirable working conditions which he is asking the unemployed to accept, no matter where they live? Is that the idea?

**Right Hon. P. E. Trudeau (Prime Minister):** Mr. Speaker, certainly with the first part of that statement I am glad there is agreement between the leader of the New Democratic Party and myself. There are some jobs available. That is all I have been saying.

**Mr. Lewis:** As unemployment in the middle of January was 635,000 and in view of the likelihood that the unemployment figures which I understand may be released tomorrow will again show that level of unemployment, higher unemployment or a few thousand lower—I do not

know what they will show—is the Prime Minister suggesting there is more than one job per 12 or 15 unemployed available anywhere in Canada at this time? Is he suggesting that all the unemployed can find jobs or that even 95 per cent of them can find jobs?

**Mr. Speaker:** Order, please. I am sure the hon. member appreciates that this is debate. For the moment I will recognize the hon. member for Prince Edward-Hastings on a supplementary.

**Hon. George Hees (Prince Edward-Hastings):** Mr. Speaker, I have a supplementary question for the Prime Minister. Can he offer any advice to those who are out of work and looking for a job other than what he offered in Victoriaville, namely, that people now leave where they are living and be prepared to work with a pick and shovel?

**Mr. Trudeau:** Mr. Speaker, I said that the opposition had spent some time over the weekend reading badly abbreviated speeches I had made. I must also say that they are probably very poor readers of those bad reports.

**Mr. Speaker:** Order, please. I will return to this subject in a moment. We will now move on to the second subject.
