Hon. C. M. Drury (President of the Treasury Board): Yes, Mr. Speaker.

Mr. G. W. Baldwin (Peace River): Mr. Speaker, I should like to ask the Minister of Justice whether he was requested to give and did he give a legal opinion as to the legality of these Governor General's warrants? If so, would he table that legal opinion?

Hon. Otto E. Lang (Minister of Justice): Mr. Speaker, we were certainly involved in the analysis of that action, and I can assure the hon. member that the action was legal and proper.
