

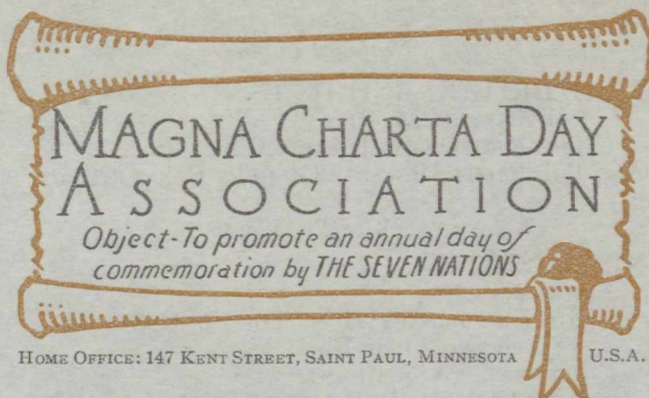

Your name is very kindly suggested by Sir John Willison, of Toronto, as a member of the Canadian National Committee for the Magna Charta Day Association.

This letterhead shows the splendid progress we have made and that President Harding is our Honorary President for this country. The standing of our National Committee is no doubt well known to you as you look over the names.

This is not a legal holiday. There is no legal organization, nor have we a regular membership with dues. We are anxious to avoid another organization.

We want one day in common for the entire English speaking race and some of our plans will make for Canadianization and more rapid amalgamation of racial strains in the Canadian body politic.

I enclose our light leaflet and a copy of the Magna Charta Study Clubs, as well as the Objects of the Association. We have other literature but I hesitate to overburden you.

A very cordial letter has been received from Mr. Lloyd-George and letters promising warm support from the Honorary Secretaries of the British Parliamentary Association in Australia and New Zealand.

May I say that, thanks to the sympathy and support of Sir James Aikins of Winnipeg, arrangements are being made to have the Provincial organization of Canadian Clubs give us their support.
