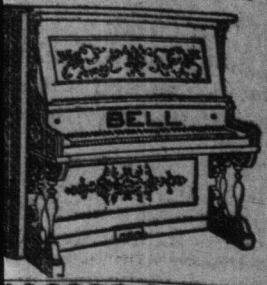

OLD RATES TO BE RESTORED

On Roads Running Between Buffalo and New York—Cut-Rate Tickets to Be Recalled.

Buffalo, N.Y., Sept. 29.—Rate-cutting by the roads running between Buffalo and New York is to be stopped at once, and the old rates are to be restored. The local agents of the different roads have been advised from New York that at a meeting of the presidents of all the New York State roads held yesterday, it was agreed to recall all cut-rate tickets and restore the regular rates at once.

CAPTAIN WASHED OVERBOARD.

Steamer Parallon's Terrible Experience in a Heavy Gale.

Port Townsend, Wash., Sept. 29.—The steamer Parallon has arrived from Lynn Canal ports, bringing 70 passengers from various sections of Southwest Alaska. On Sept. 26 the Parallon picked up the wrecked schooner Capella in the North Channel and towed her to Bella Bella. The Capella sailed from Seattle Sept. 16 for Wrangell, and, on Sept. 20, when 100 miles off Cape Flattery, a heavy gale was encountered. The little schooner's boats and hatches were carried away, and Captain Jones Nordland was washed overboard and drowned. H. L. Jones was struck by a boom, and had several ribs broken. When the schooner was picked up she was in a water-logged condition, and all the supplies aboard were spoiled.

CELESTIAL IN TROUBLE

Yang Chai is Accused of Doing a Sharp Trick.

Yang Chai, a burly Chinaman, was put on trial yesterday at the Sessions on the charge of doing Lee Den a sharp trick of \$150 by fraud. At the opening of the trial there was a dispute between Crown Attorney Dewart and Mr. Y. Chai, for the defendant, as to the selection of an interpreter. Finally Tom Yung was chosen and the case commenced. The evidence showed that the accused met Lee Den in a house at 104 John-street, when negotiations were entered into by which Lee Den was to be safely escorted into Uncle Sam's domain. Chai then went to Brantford and the prosecution was instituted. Judge McDougall will address the jury this morning.

PROBABLY A CLEVELAND SAILOR.

Body Found at Port Rowan Had Cards Upon It Indicating That

Simcoe, Ont., Sept. 29.—(Special.)—Yesterday, while out hunting, the Smith brothers of Port Rowan, found the body of a middle-aged man, dressed in dark clothes, on the south shore of Long Point. The body had been washed up on the shore, and the head and shoulders were covered with sand. Dr. Hayes, coroner, was summoned by wire to Port Rowan, where the body had been taken, but it was thought unnecessary to hold an inquest at present, and Constable Archie Thompson was directed to bury the body, and mark the spot. In the button-hole of the dead man's coat was found a card with C. & B. Line on it, and in his pockets were several postal cards, other cards and letters, but the water had made them illegible. One envelope was addressed to William A. Barnes, 107 River-street, Cleveland, Ohio. Another card was from Fred Bates, St. Williams street, Buffalo, N.Y. Part of an envelope read from A. Galbraith, dealer in dry goods and notions, Mantua Station, Ohio, and another, Mantua Station, Ohio, 601 Central-avenue, Cleveland. Dr. Hayes has telegraphed for information to the Chief of Police at Cleveland, but has received no reply as yet. The supposition is that the deceased was an employee of the Cleveland & Buffalo line of boats.

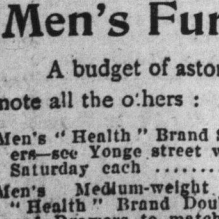
