EDITORIAL

ITS UP TO YOU COWANSVILLE

What are you going to do about it, Voters of Cowansville. There is a saloon in our village that must be got rid of. Are you going to get rid of it this year and join in the grand march of onward progress and keep step with community after community of our fair Dominion? Or are you going to remain stationary, a back eddy in the stream of advance? Cowansville is noted as being more or less of a progressive village. Will it still keep its name as progressive or will it remain sunk in intemperance?

We have a whisky council. There is no use mining matters. We have a set of men as our village fathers who are heart and soul with our local hotel keeper. They want licensed whisky and will not refuse a license to sell whisky unless they are absolutely forced by the voters of Cowansville to refuse it.

Do such men actually represent the sentiments of the majority of the voters of Cowansville? We do not think so. They may represent a few barroom frequenters and a few of the older men who love their whisky. But the vast mass of the citizens of Cowansville are total abstainers.

There are two ways of freeing the village from the saloon. One method is to turn the present three retiring councillors out of office and replace them with pledged prohibitionists. The other method is to present a petition to the council against the saloon. If the petition be signed by a majority of the resident municipal voters the council will be powerless to grant a license. It is up to you, citizens of Cowansville.

COWANSVILLE AND SWEETSBURG

One of the favorite arguments of the so-called respectable element which favors a license continuation for Cowansville is that there is a license at Sweetburg a bare two miles away, and the argument is that if the license is taken away from Cowansville the drinkers will go to Sweetburg, buy a sufficient quantity of alcoholic beverages to get drunk on, and consume the beverage on the road home. This would result in a continuous stream of drunken men between Sweetburg and Cowansville, and the respectable and high-toned Main street of Cowansville would be rendered vulgar and disagreeable by drunken scenes. This is the argument put forth by the whiskyites of Cowansville. The argument is that the Cowansville license should not go until the license goes from Sweetburg.

It is impossible at present to pry the voters of Sweetburg free from their licensed bar. The majority of the voters of Sweetburg cling to their licensed barroom almost as closely as they would to a long lost brother and the Cowansville whiskyites know this.

Their argument is tenuous at best. A two-mile walk at night is a long way to go for a drink. If drunks become numerous along Main street, the village could put two constables on the street and station them at the outskirts of the village on the Sweetburg road. If any drunken men come from Sweetburg, the two constables could arrest them and take them back to Sweetburg jail. It would be a sort of poetic justice were drunks on Sweetburg whisky returned to Sweetburg to be punished.

If Cowansville got rid of its license certain individuals no doubt who now patronize Cowansville for their whisky would patronize Sweetburg. This would be a gain for Cowansville, and after a year or two Sweetburg would become tired of being the meeting place of men who want to satisfy their bestial appetites.

VESTED INTERESTS

If the license were cut off from Cowansville there are certain men who would lose money. There is no use denying the fact. But, thank Heaven, we in Canada have not got down to the low stage of the English nation where the right to make your fellow men intoxicated is vested right.

The men who will lose money by a refusal of a license should not have put their money into the business. If men will go into the trade for the sake of becoming wealthy they should be the last to object when the moral sense of the community rises and spurs their business out of existence.

Licensed hotel life is low in moral tone. We have lived long enough in a licensed hotel to recognize this fact. A community is cleaner and purer and better by the elimination of the saloon. The hotel has got to go from Cow-

ansville as a licensed proposition. It may not go this year but in two years it will be gone. Those merchants and business men who hold that a licensed hotel is necessary for business will see their mistake. A licensed hotel is no more necessary for business than is an elephant for Canadian travel. Business will go where their is business and if commercial travellers say they will not come to Cowansville because there is no booze here, it will be ten chances out of ten that their firms will fire them for incompetency and insubordination.

There is no vested interests in an hotel for the ordinary business man. He loses money by its existence. And those who have paid big money for a licensed proposition in Cowansville ought to lose their money for their foolishness. They had plenty of warning of the feeling against them before they landed in our town.
