

Of the Ontario and Rainy River Railway Company, a Company incorporated by an Act of the Legislature of the Province of Ontario; praying for the passing of an Act declaring their work to be one for the general advantage of Canada; confirming certain agreements made with the Port Arthur, Duluth and Western Railway Company, and otherwise amending and extending their Charter.

Of the London and Canadian Loan and Agency Company, Limited; praying for the passing of an Act amending their Act of incorporation.

Of the Empire Printing and Publishing Company, Limited; praying for the passing of an Act amending their Act of incorporation, enabling them to increase the number of their Directors.

Of Mary A. Borrowman, and others, members of the Baptist Church in the Town of Barrie; of Minnie Peacock, and others; and of William Harker, and others, Railwaymen of Allandale, in the Province of Ontario.

Of Mrs. E. E. Woodruff, and others, of the Methodist Church, in the Town of Morden; of the Reverend Thomas W. Pickett, and others, of the Methodist Church; of Auguste Magnusson, and others, of the Lutheran Church, in the City of Brandon; of J. McLaren, and others, of the Presbyterian Church, in the Town of Morden, all in the Province of Manitoba, severally praying for the passing of an Act prohibiting the importation, manufacture and sale of all alcoholic liquors for all beverage purposes;—and

Of the Crow's Nest and Kootenay Lake Railway Company, a Company incorporated by the Legislature of the Province of British Columbia; praying for the passing of an Act declaring them a body corporate within the jurisdiction of the Parliament of Canada.
