THEREAS an Act was passed in the Forty-eighth year of Your Majesty's Reign, intituled, "An Act to continue, for a limited time, an Act passed " in the Forty fifth year of His Majesty's Reign, intituled, " An Act to ratify and confirm the provisional articles of agreement entered into by the respective Commisfioners of this Province, and of Upper Canada, at Montreal, on the fifth day of July, One thousand eight, hundred and sour, relative to Duties, and for carrying the same into effect," And also, further to continue an Act passed in the Thirty-leventh year " of His Majesty's Reign;" which articles of agreement and which Acts will expire on the firsft day of May, which will be in the year of Our Lord One thousand eight hundred and fourteen; and, in order to avoid the necessity of making a new appointment of Commissioners, it is expedient, that the said A& passed in the fortyfifth year of Your Majesty's Reign, and the said Provisional Agreement, and also. the aforesaid Act, passed in the thirty-leventh year of Your Majesty's Reign, be further continued for a limited time; May it therefore please Your Most Excellent Majesty, that it may be enacted, and be it enacted by the King's most Excellent Majesty, by and with the advice and consent of the Legislative Council and Asfembly of the Province of Lower Canada, constituted and affembled by virtue of and under the authority of an Act passed in the Parliament of Great Britain, intituled, "An Act to repeal certain parts of an Act passed in the fourteenth year " of His Majesty's Reign, intituled, " An Act for making more effectual Provision of for the Government of the Province of Quebec in North America," and to make further provision for the Government of the faid Province; ' And it is hereby enacted by the authority of the same, that the above mentioned Act, passed in the fortyfifth year of His Majesty's Reign; and he said provisional Articles of Agreement, as also, the aforesaid Act passed in the thirty seventh year of His Majesty's Reign, and each of them and all and every Article, Chanle, Obligation, Penalty, Fine, Forfeiture, matter and thing therein contained, be, and the same is, and are hereby continued.
